These two new Directors replace Cristina Aldámiz-Echevarría and Ángel García Altozano, on behalf of ACS, to whom the Board of Directors has expressed its gratitude for their important contribution to the MASMOVIL project, which they will continue to support from their respective positions in their company.

With these two new appointments, MASMOVIL Group reinforces the independence of its Board of Directors. After these changes, the number of Directors remains the same at 12, but the number of independent Directors increases to 5, including its Chairman, Eduardo Díez-Hochleitner R.



# Onchena, Indumentaria Pueri and the Group management continue their strong bet to the MASMOVIL project

In addition, recently, Onchena and Indumentaria Pueri, two of the main shareholders of the Company, and several members of the Board of Directors and Managers of the Group, have reinforced their commitment to the MASMOVIL business project.

Specifically, **Onchena** reiterates its commitment to MASMOVIL, increasing its stake participation in the Company to 14.45%, after an additional 4.2M€ investment. Meanwhile, **Indumentaria Pueri** has increased **its participation in MASMOVIL to 8,80%**, from the previous 8,70%.

Furthermore, as a demonstration of confidence in the project and its potential capacity to generate value for its shareholders, the CEO of MASMOVIL, together with several members of the Board of Directors and the Company's management team, invested a few weeks ago close to 1,4M€ in the acquisition of close to 80,000 shares of the Group at an average price of around 17.4€ per share.


## **CV Nathalie Picquot**

The MASMOVIL is the fourth telecommunications operator in Spain, offering services for fixed line telephone, mobile phone services, and internet broadband for home use, companies and operators under its principle brands: Yoigo, Pepephone, MASMOVIL, Lebara y Llamaya.

The Group holds a fixed infrastructure of Fibra/ADSL and mobile 3G and 4G. At present it is capable to serve more than 15.2 million of homes with optic fiber and 18 million more with ADSL. Its 4G mobile network covers 98.5% of the Spanish population. The Group has more than 8 million clients in Spain.
